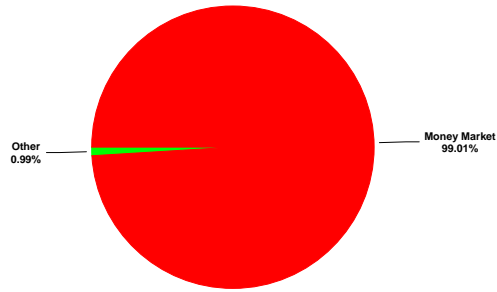

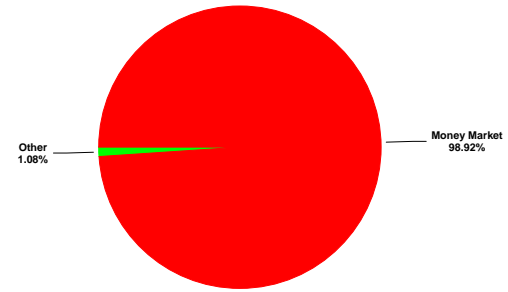

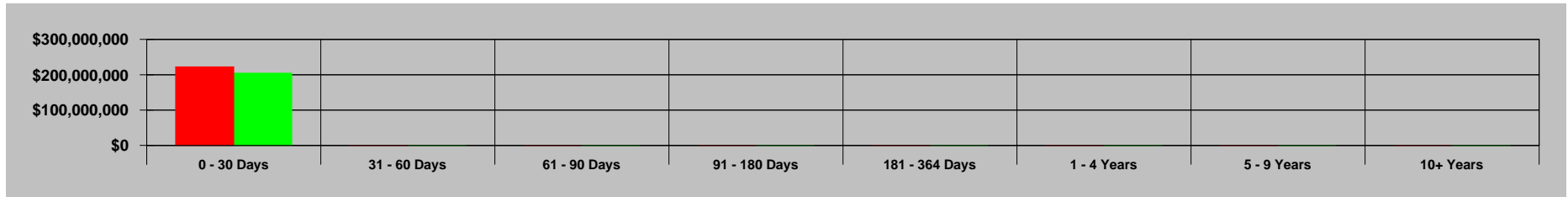
### Portfolio Composition - 09/30/10



### Portfolio Composition - 10/31/10

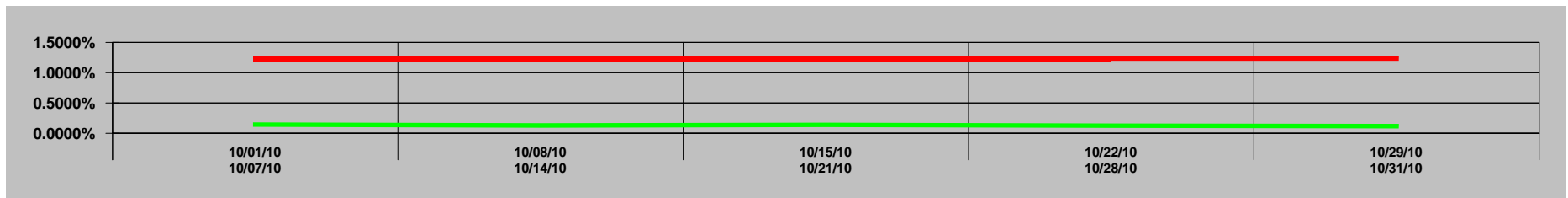


### Maturity Aging - 09/30/10 vs 10/31/10

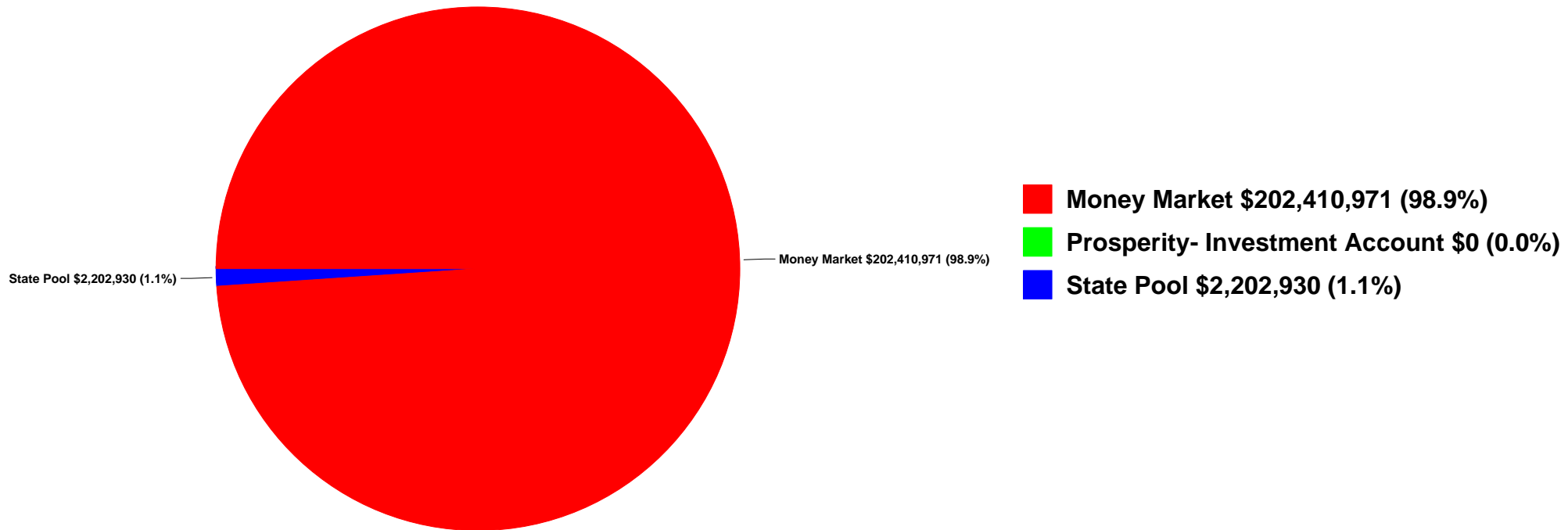

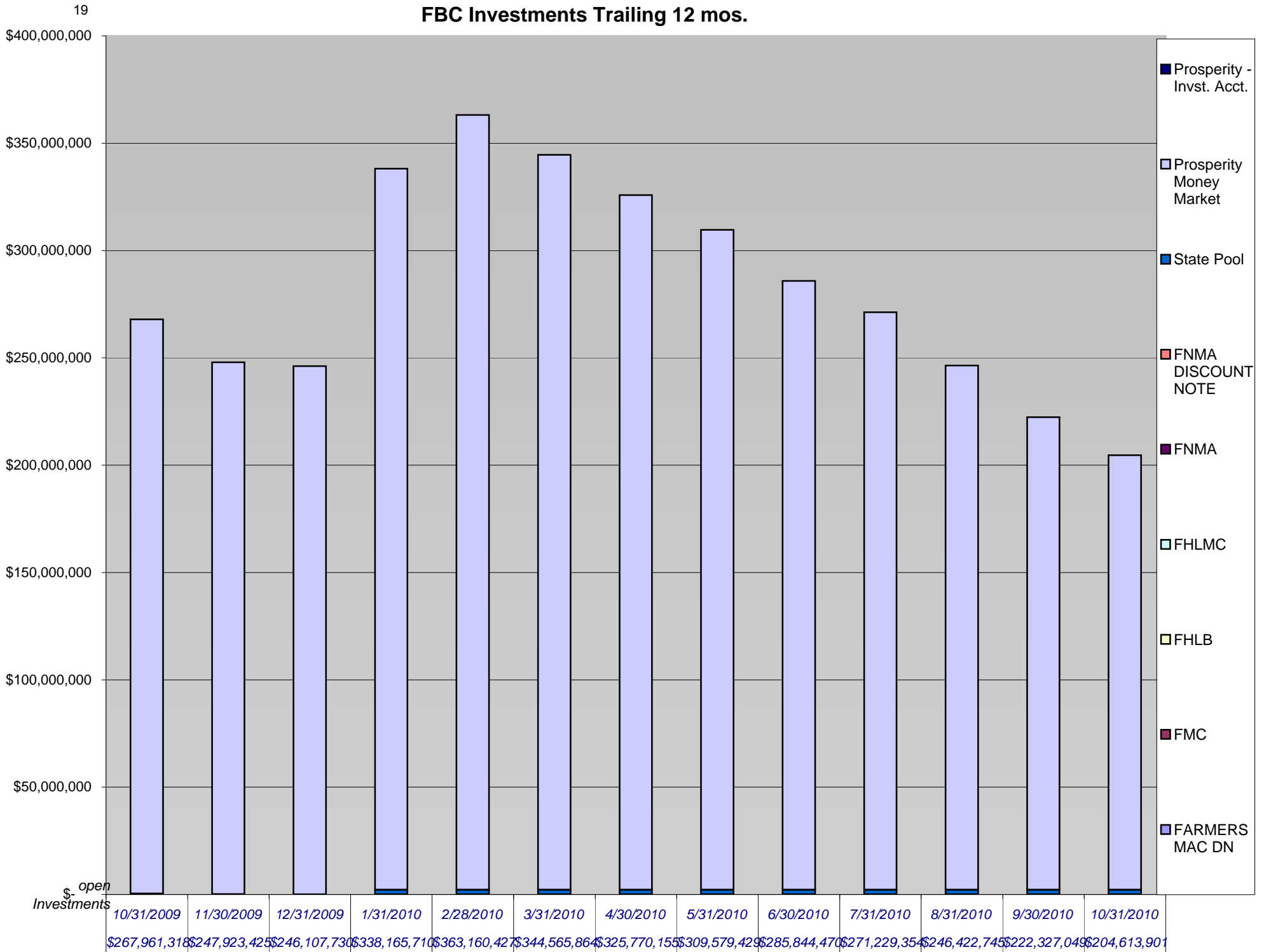

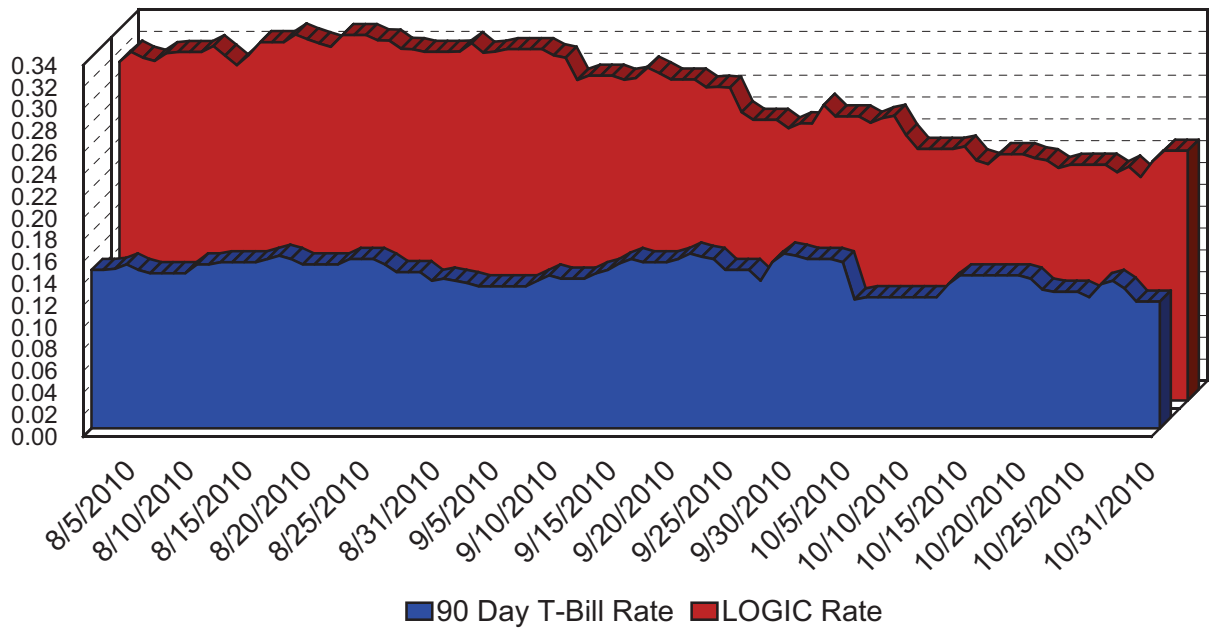
