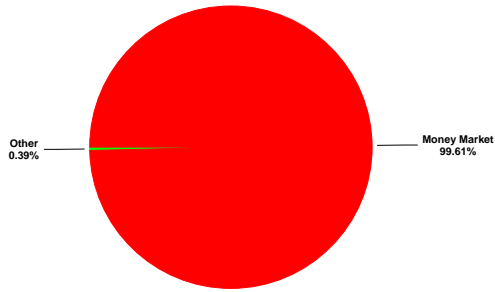

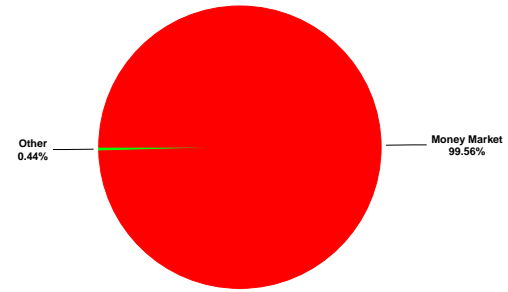

Portfolio Composition - 03/31/13

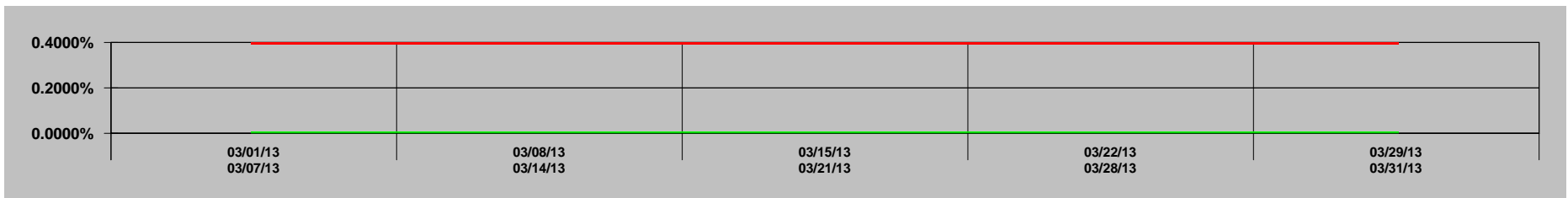


Maturity Aging - 02/28/13 vs 03/31/13

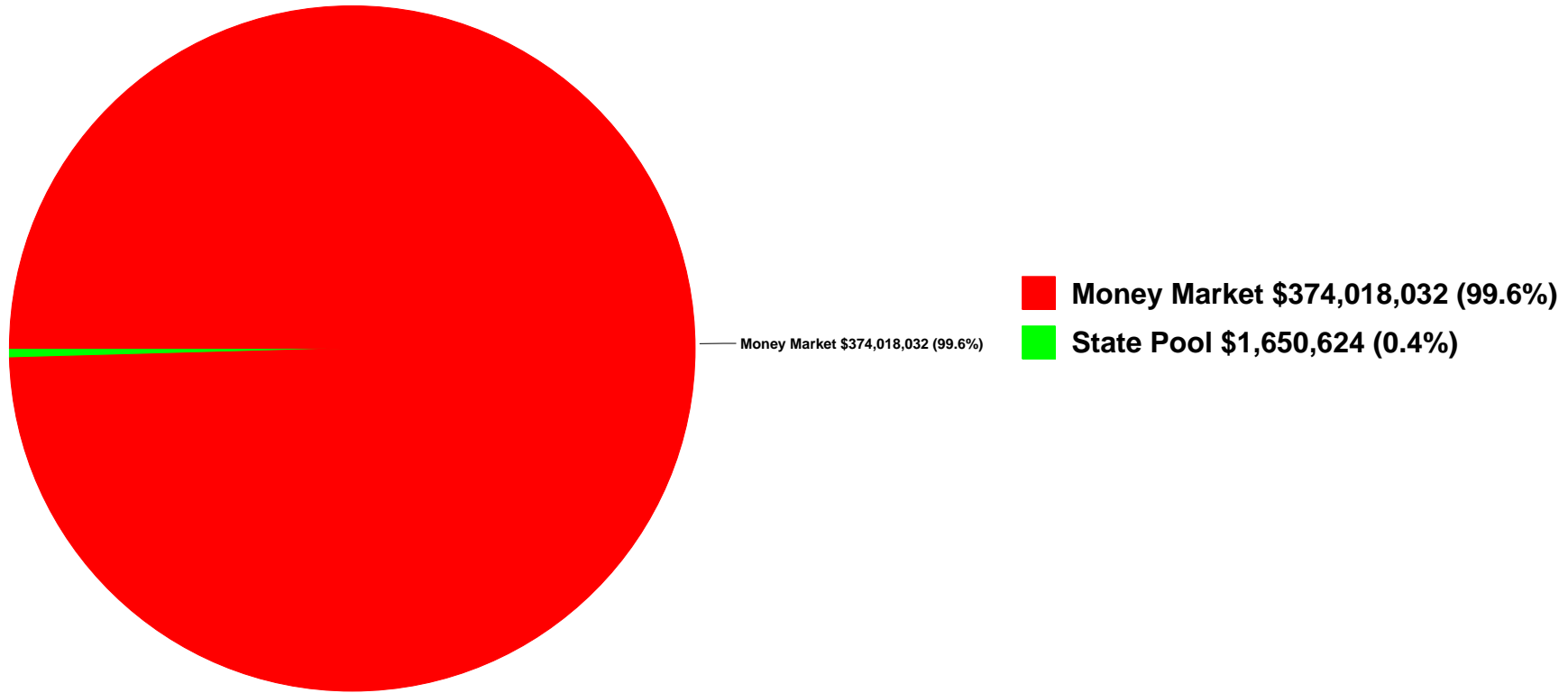

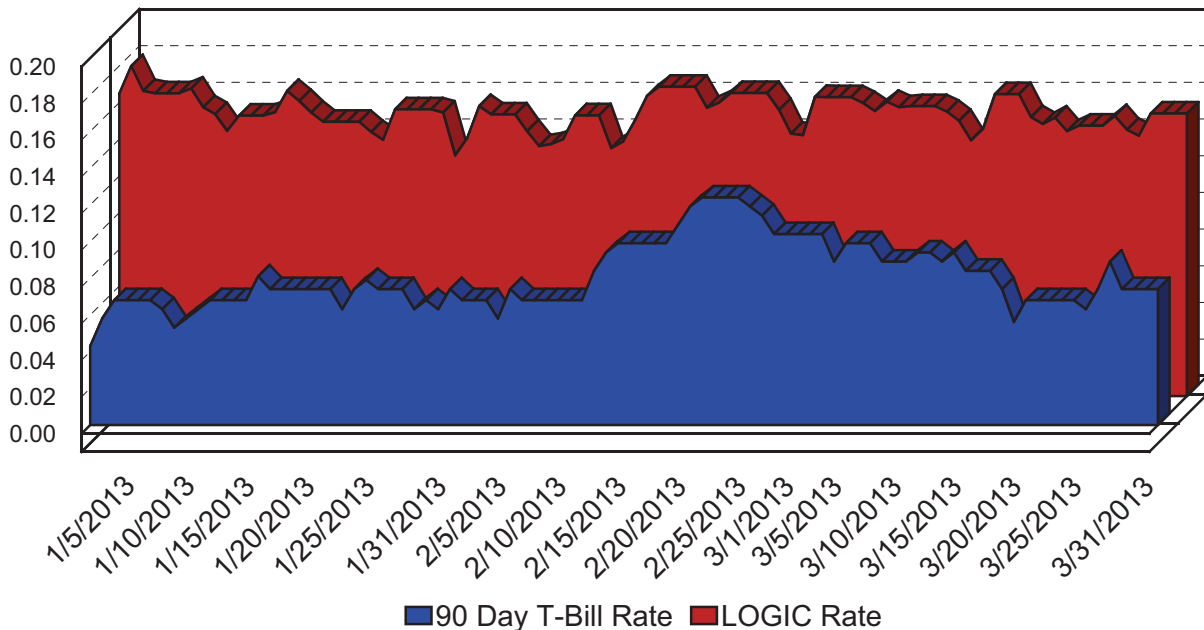
