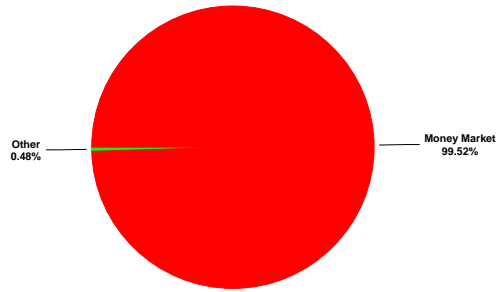

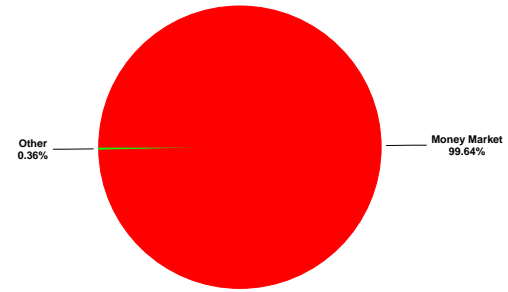

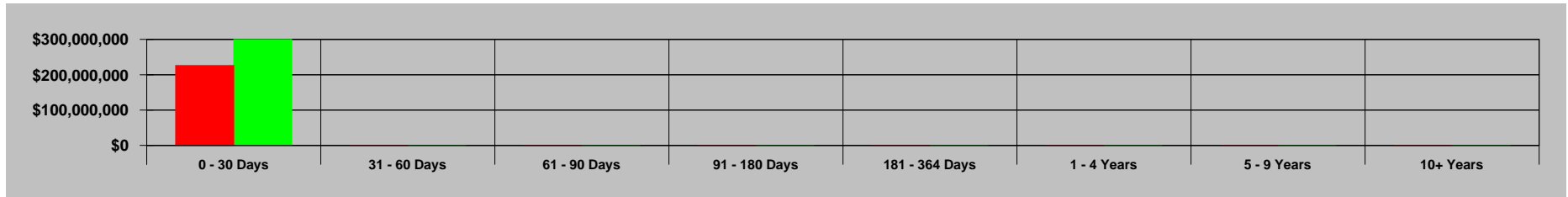
Portfolio Composition - 12/31/13



Portfolio Composition - 01/31/14

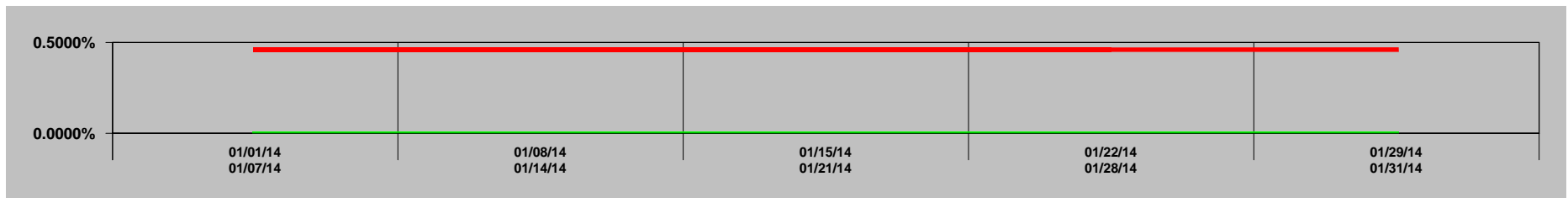


Maturity Aging - 12/31/13 vs 01/31/14

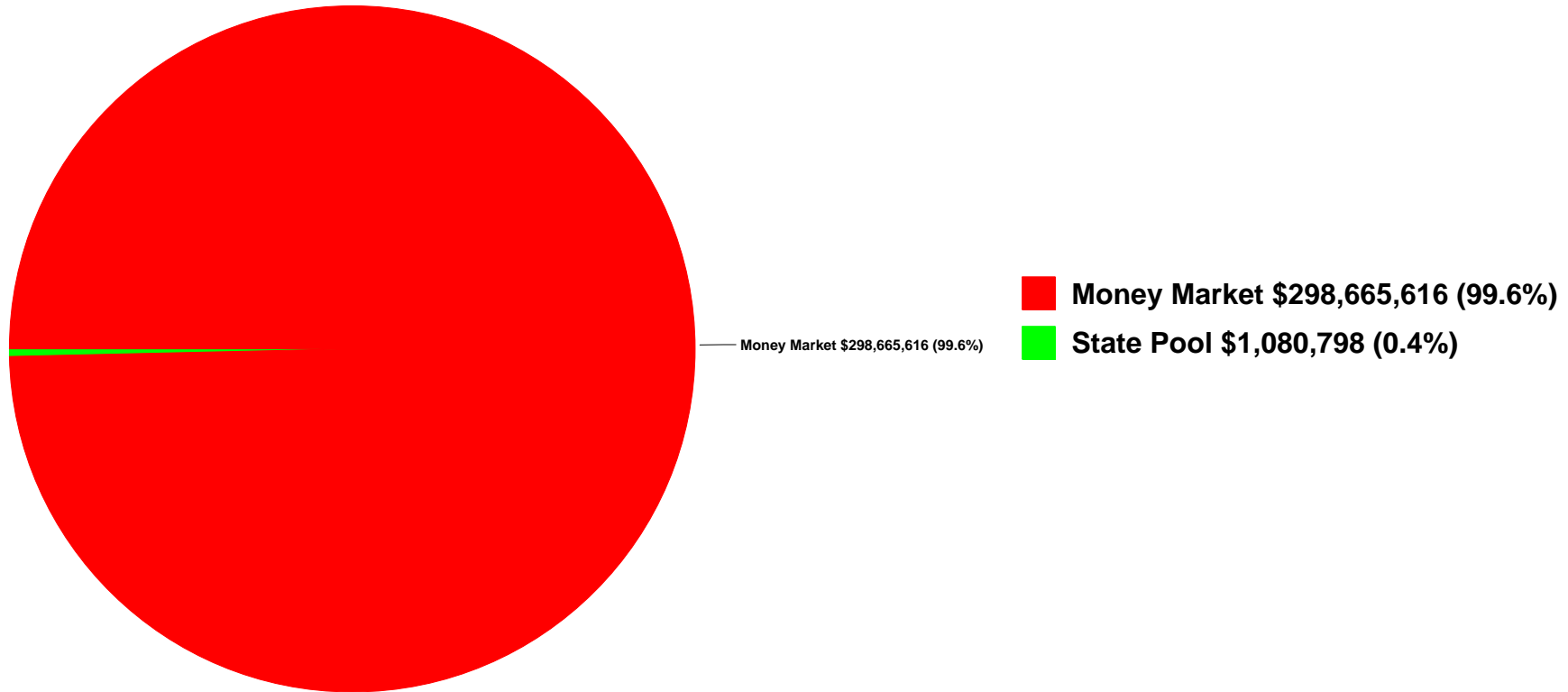

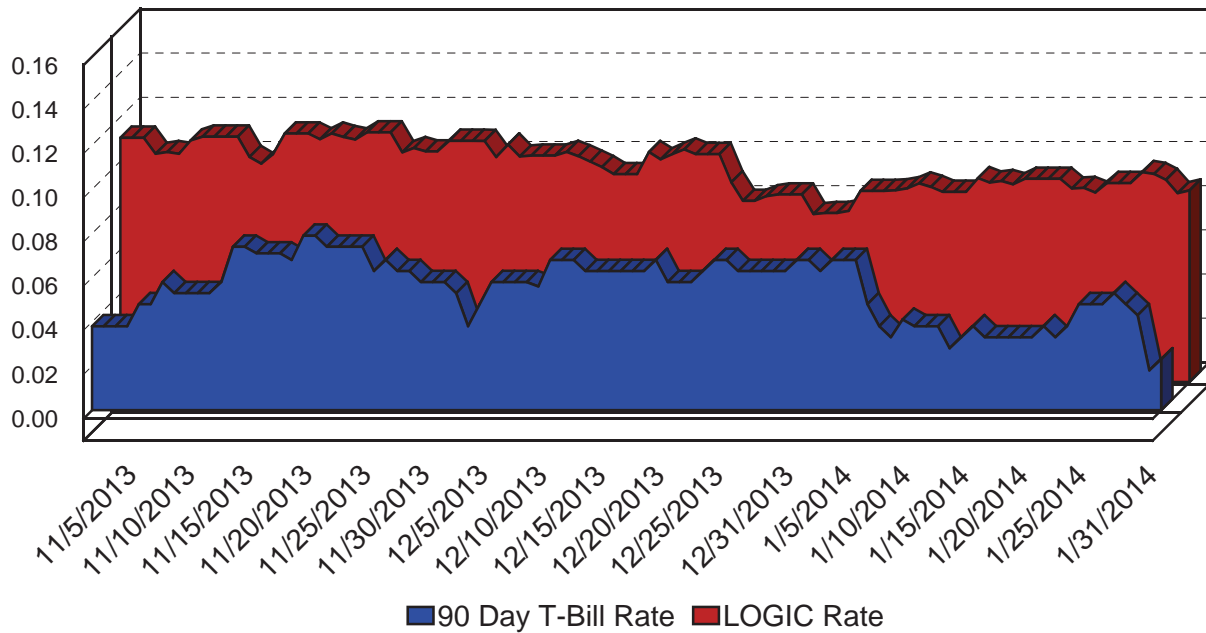
