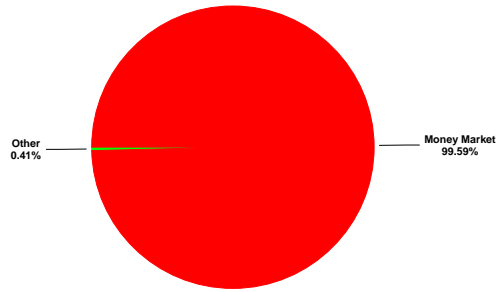

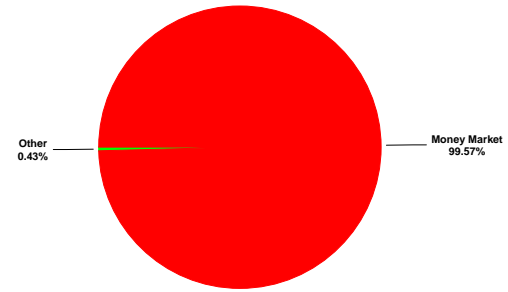

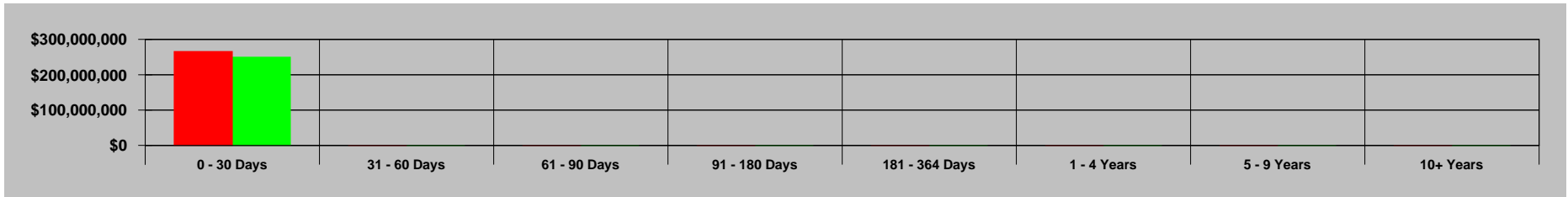
Portfolio Composition - 04/30/14



Portfolio Composition - 05/31/14

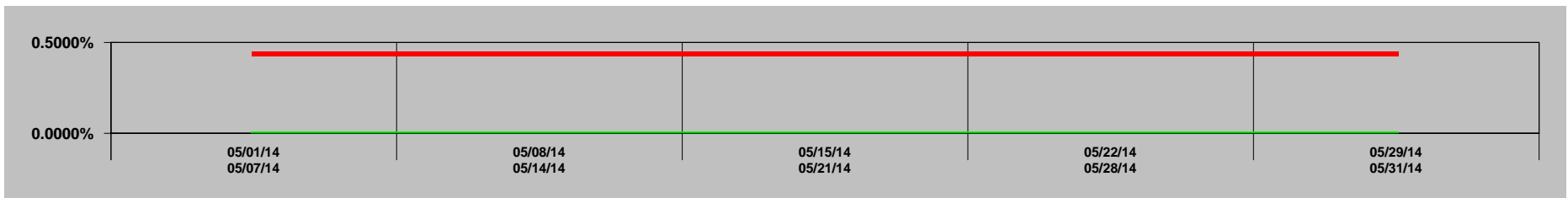


Maturity Aging - 04/30/14 vs 05/31/14

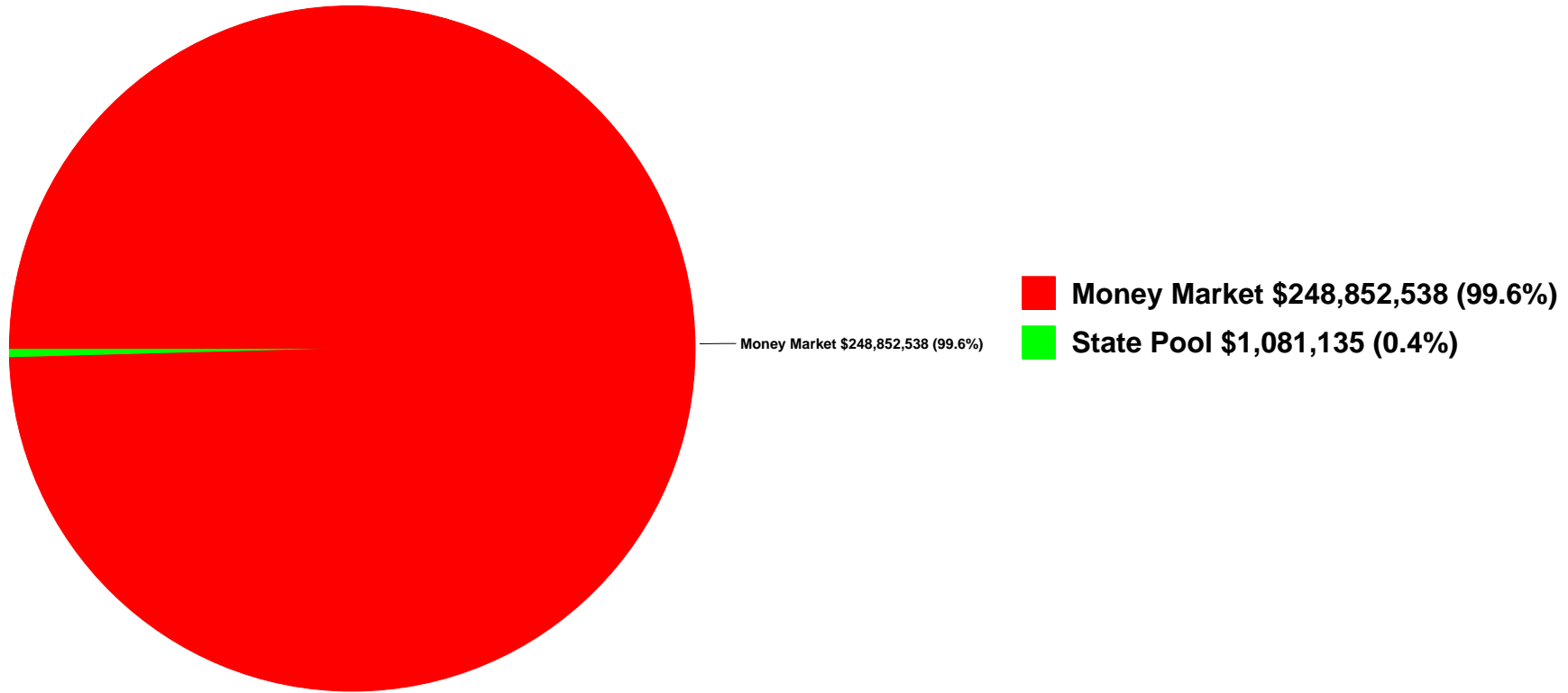

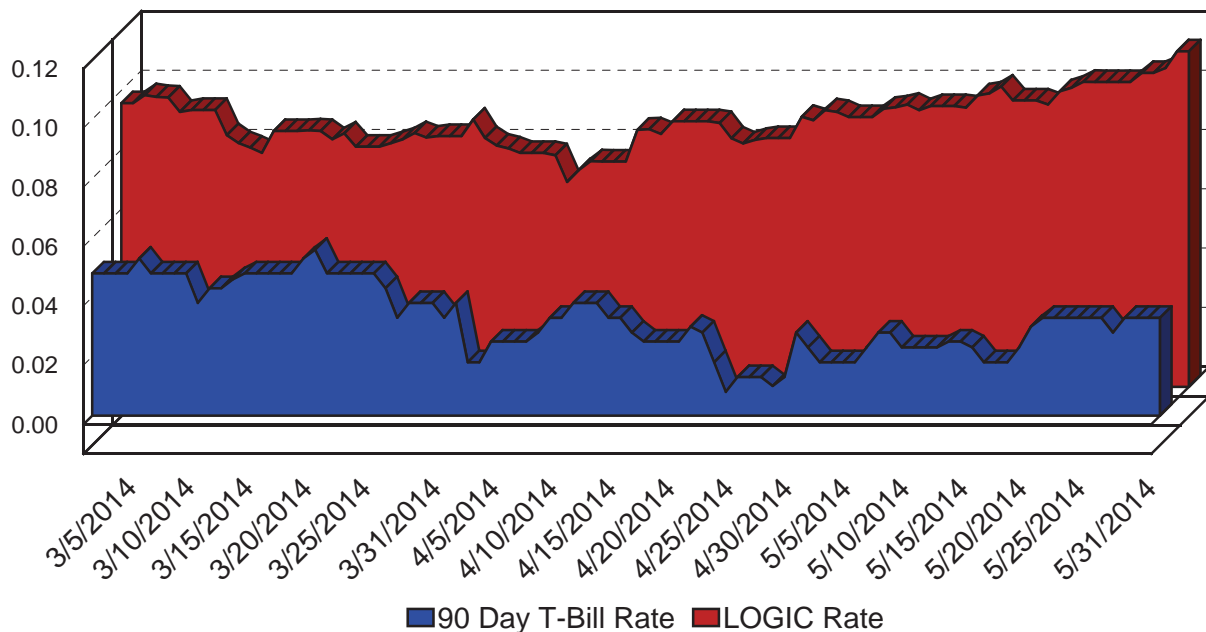
