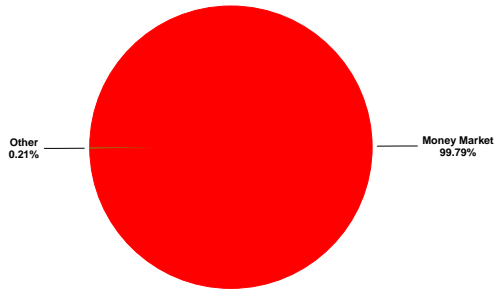

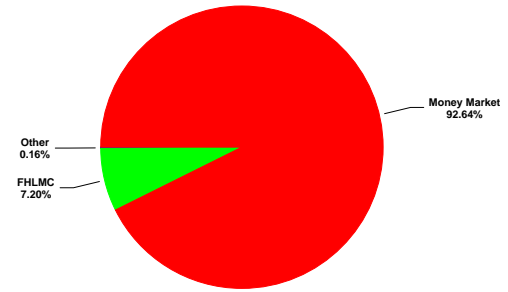

Portfolio Composition - 06/30/16

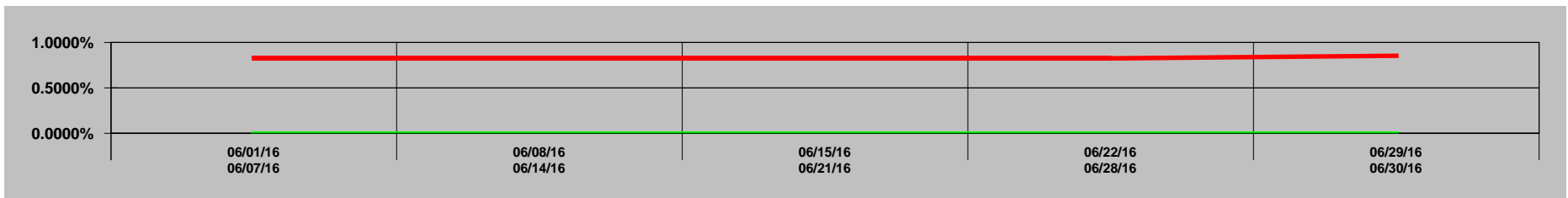


Maturity Aging - 05/31/16 vs 06/30/16

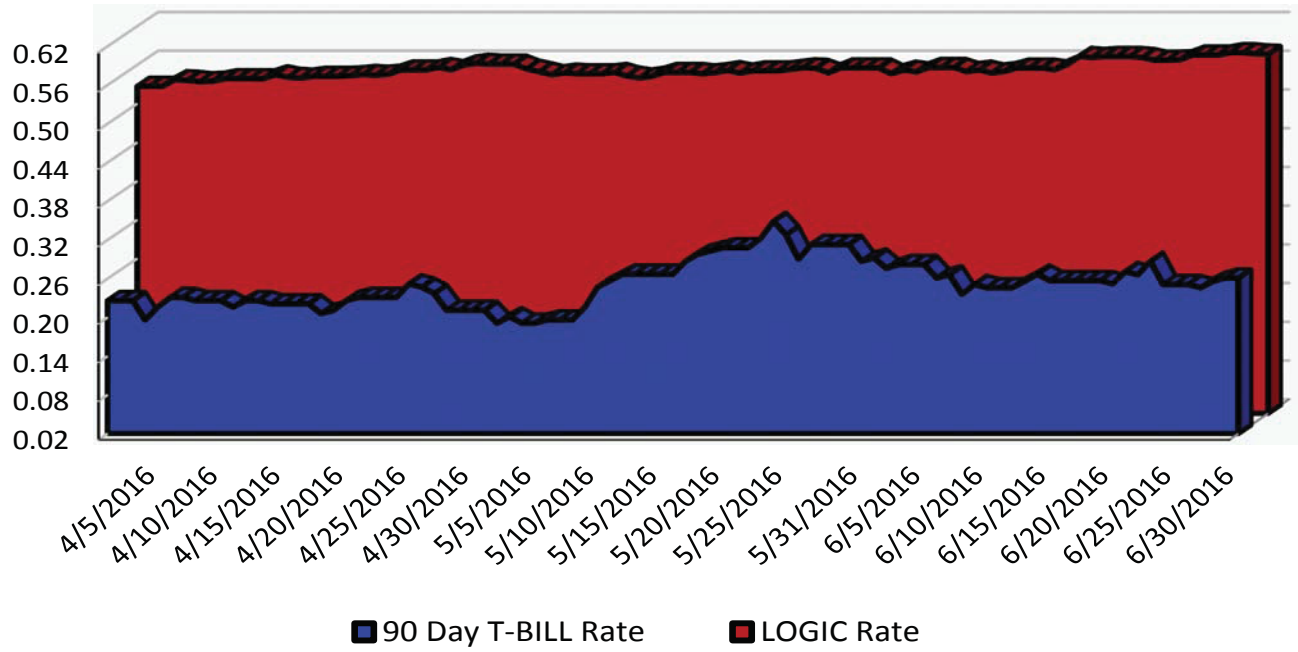
